 2. Allotment Memo received online
 3. Receipt of Tuition Fee remitted through allotment
 4. Certificate to prove date of birth
 5. Original Transfer (TC) and conduct certificate from the institution last attended
 6. Original mark list of the qualifying examination (Higher Secondary or Equivalent) and pass certificate (if applicable)
 7. Eligibility certificate from any university in Kerala, in case of candidates who have passed a qualifying examination other than Higher Secondary examination/Vocational Higher Secondary examination conducted by the Govt. of Kerala or the examination conducted by CBSE/ICSE/ISCC and / or degree from other universities or Boards
 8. Migration certificate , if applicable
 9. Physical fitness certificate in the relevant format obtained from a medical practitioner not below the rank of Asst. Surgeon given in Annexure V(e) of the prospectus 2020
 10. Certificate showing that the candidate has got himself or herself vaccinated against Hep.B
 11. Income certificate from concerned Revenue Authority
 12. Undertaking as per clause 14.2 vide Annexure VII
 13. Any other document required to be produced by the head of institution

- **For Candidates who belongs to reservation category :**
 1. Nativity of the candidates
 2. Valid Non Creamy Layer Certificate – for communal reservation seat

 4. For fee concession to OEC category – certificate to prove community
 5. Fee concession to those as is given to OEC – Certificate to prove community and income certificate are required
